Dear NRI Brothers & Sisters,

Namasthe,

As you are all aware, Amaravati is the capital city of the newly formed Andhra Pradesh, and historically, it was under the Kakatiya dynasty. This area which is being called "Kammanadu" was under the rule of Kakatiya kings. This area was last ruled from Dharanikota as the capital, by Sri Raja Vasireddy Venkatadri Nayudu. And, Smt. Rani Rudrama Devi's maternal relations were from this region.

After the bifurcation of the unified state in 2014, the Andhra Pradesh Government had acquired 33,000 acres of land from the farmers of Thullur mandal to raise the Capital Amaravati from scratch. It was possible just because of the sheer brilliance of Sri Chandra Babu Naidu, and the trust the farmers of Thullur Mandal had on him as a leader par excellence. Amaravati is going to be the number one Capital in the country soon. As a parallel sequel to this development, our community elders have decided to form a non-profit organization called "KAKATIYA CONVENTION SOCIETY" to serve and help the current as well as future needs of generations of our community. We have currently a robust strength of 500 members in our society.

To cater to the various needs and plans, our society has acquired 15 acres of land in Mothadaka village which is quite close to the Capital as well as to Guntur. The foundation stone was laid in April, 2019, and our centre is well accessed by all the main roads. Our KICC is quite close to the airport, Secretariat, High Court, Capital City and the inner ring road.

We would like to give a brief account of the facilities / services that are going to be provided by our society:

- Kakatiya Convention Hall (with 3,000 seating capacity),
- A mini Convention Hall (with 1,000 seating capacity),
- Club House for members with Gym and facilities for Indoor and Outdoor games),
- Two dining halls with air-conditioning,
- Old Age Home,
- Conference Rooms, Open Air Theatre, Swimming Pool
- Accommodation: 100 Guest Rooms with air conditioning,
- Restaurant – Vegetarian & Non-Vegetarian,
- Reception and Office Block, First – Aid Service with Ambulance, Travel Desk,
- Mini Super Market for members,
- Mini Library & Digital Library,
- Educational Academy for coaching State & Central Services like Group-I, Group-II, I.A.S., I.P.S., I.R.S.,
- Sports Academy to train for National Sports & Games,

Old Age Home (KAMMA VARI PRASANTHI NILAYAM):

Many young people from this area have gone abroad seeking bright future and to lead a peaceful life with better standards. But the dependant parents and senior citizens have to stay back in their respective homes without proper moral and emotional support. The youngsters while leaving the country would leave with a heavy heart as they cannot take their parents also along for various obvious reasons like the visa rules. Some senior citizens want to live independently without being a burden to their children and other family members. They deserve a better life with a close knit community and with all the necessities being looked after by somebody at a reasonable cost. We provide to

the senior citizens what they miss in their respective homes. We are hopeful and confident that the senior citizens would have a large joint family as a "Vasudaika Kutumbam" once they become inmates of this Old Age Home.

Considering these factors, KICC has decided to construct an Old Age Home in its premises. At present we intend to take in only 100 inmates into the old age home and later, as the need arises, we may expand further.

In the light of what has been planned on an ambitious level, we invite and seek donations from the members and our community.

Statues of those persons as suggested by the major donors, will be erected in the Old Age Home or KCS premises, and who will be eligible as major donors will be decided by the management.

If a donor contributes Rs. 5,00,000/- (Rupees five hundred thousand only), his or her name plate will be prominently placed on an executive room. The donor may choose his / her parents or grand-parents, whose name will be displayed.

Donors will get priority and concession in charges for the use of old age home.

Use of Old Age Home is open to Donors, Life Members and their relatives on priority basis.

Right of admission to home and the charges to be paid by users will be decided by the management of KICC.

Required medical assistance like nursing care, doctor visits and ambulance service in case of emergencies will be provided.

We have decided to celebrate the birthdays, Mother's / Fathers' Days for the well-being of the senior citizens. In the unfortunate eventuality of an inmate of old age home passing away, and if the children of that particular inmate are away and are not in a position to visit on time, we are even prepared to take care of the cremation and other related rituals as the inmates deserve to be treated with dignity in their last journey.

Our Motto: "OUR SENIOR CITIZENS SHOULD LEAD A DIGNIFIED AND DECENT LIFE".

We offer the following facilities to NRI Members who pay Rs. 3,03,000/- (Rupees Three hundred and three thousand only) towards membership in KICC:

- Life Membership with hereditary rights,
- All the facilities provided by KICC can be enjoyed within the framework of the existing norms and rules,
- Whenever you visit India, guest rooms can be used freely for 5 days in one calendar year or the same can be accumulated for later use.
- If you are a donor of Guest Rooms, your name plate will be affixed for that room, and you can utilize the room freely for another 5 days,
- Old age home donors will get priority in allocation of rooms, and concessions in rental charges.
- Dr. Yerra Nageswara Rao is a well known physician in Guntur, and has been serving as the current president of the executive committee of KAKATIYA CONVENTION SOCIETY. He has generously donated Rs. 1,00,00,000/- (Rupees One Crore Only) for the construction of old age home. We sincerely thank Dr. Nageswara Rao for his generosity and we seek and request the NRI community to emulate Dr. Nageswara Rao by donating to this noble cause with equal enthusiasm. Many of our other friends have also donated very generously so far.

Membership – NRI WING :

Membership is open to only Kamma Community,

NRIs (Non Resident Indians) and OCIs (Overseas Citizens of India) are eligible,

There are 500 members as Life members at present, and this number will be increased to 700,

Members will be admitted only on paying Rs. 3,03,000/- (Rupees Three hundred and three thousand only) along with 2 passport size photos, and a xerox copy of their passports in case of NRIs, and xerox copy of aadhaar card, and PAN card along with 2 passport size photos in case of resident Indians.

We once again solicit your membership, donations either in your names or in the names of your parents / grand parents.

We humbly request you to kindly pass on this information to your relatives and our community friends also.

We look forward to your participation in this noble cause.
